#### THE FAIRS ACT, 1871

The Local Government Act, 1894

STAFFORD MAY PLEASURE FAIR.

Whereas a representation has been duly made to me, as Secretary of State for the Home Department, by the Stafford Town Council to the effect that it would be for the convenience and advantage of the public that the Fair which has been held annually in the

Borough on the 14th day of May should be abolished

And whereas notice of the said representation and of the time when I would take the same into consideration has been duly published in pursuance of the Fairs Act, 1871

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the said Fair should be abolished

Now, therefore, I, as Secretary of State for the Home Department, in exercise of the powers vested in me by the Fairs Act, 1871, do hereby order that the Fair which has been held annually in the Borough of Stafford on the 14th day of May shall be abolished.

#### PRISONS, ENGLAND

Rule made under Section 30 of the Prison Act, 1877, with reference to H.M. Prison at Ipswich.

Whereas H.M. Prison at Ipswich is situate wholly within the Borough of Ipswich, but that part of it which was, before the passing of the Prison Act, 1877, the prison of the County of Suffolk, remains within the jurisdiction of the Coroner for the said county

Now, by virtue of the power vested in me by Section 30 of the Prison Act, 1877, I do hereby direct that the said prison shall for the purpose of inquests to be held on any persons dying therein be considered to be the prison of the said borough and within the jurisdiction of the Coroner for the borough
