The Civil Service Commissioners hereby give notice that the following Regulations are published with the consent of the Lords Commissioners of His Majesty's Treasury, viz.:—

TEMPORARY (RECONSTRUCTION) REGULATIONS FOR THE FILLING OF APPOINTMENTS AS INSPECTOR OF FACTORIES (MEN).

1. *Age.*—Candidates must have been born on or after 2nd August, 1884, and not later than 1st August, 1896. Provided that a candidate born on or after 2nd August, 1881, and not later than 1st August, 1884, will be eligible (a) if, for at least seven years, he has been occupied in one or more of the following capacities in a factory or workshop, or in engineering work, viz.:—Master, Manager, Foreman, Workman, or Apprentice, and has thereby acquired practical acquaintance with industrial methods and conditions; or (b) if he has served as Factory Inspector's Assistant, with the certificate of the Civil Service Commissioners, from a time when he was under 30.

2. *Nationality.*—A candidate must be a natural born British subject, and the son of a father also a natural born British subject; provided that exception to the latter condition may be made in the case of candidates who have served in His Majesty's Armed Forces during the war.
