

II. RIVER THAMES AND APPROACHES —CAUTION WITH REGARD TO RE- PLACEMENT OF AIDS TO NAVIGA- TION.

Mariners are notified that the navigational marks in the River Thames and approaches are in process of replacement. The Barrow Deep channel will be available for navigation from 1st October, 1919, but Mariners are cautioned that the seamarks are not in all cases exactly in their pre-war positions.
