such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas under the regulations for the government of Your Majesty's Naval Service Naval ratings employed in Your Majesty's Dockyards are entitled, under certain conditions, to extra pay:

"And whereas Dockyard Workmen employed in Your Majesty's Dockyards on work of a particularly objectionable character in confined spaces are paid extra pay not exceed-

ing 3d. an hour while so employed:

' And whereas the necessity arises from time to time for the employment of Naval ratings in Your Majesty's Dockyards on work of a similar

" And whereas we are of opinion that Naval ratings while so employed should receive, in addition to the extra pay to which they are entitled as aforesaid, extra pay, not exceeding 3d. an hour, of the same amount and under the same conditions as would have been payable had they been Dockyard Workmen:

"We beg leave humbly to recommend that your Majesty will be graciously pleased, by Your Order in Council, to sanction, with retrospective effect from the 30th day of January, 1919, the payment to Naval ratings, when employed in Your Majesty's Dockyards on work of a particularly objectionable character in confined spaces, of extra pay of such amounts, not exceeding 3d. an hour, as would under like conditions be paid to Dockyard Workmen. '' The
