- (14) part of the Parish of Wentworth,

which Townships and Parishes are at present wholly included in the Rural District of Rotherham;

- (15) the Parish of Bradfield,
- (16) the Township of Ecclesfield,
- (17) the Township of Tankersley,
- (18) the Township of Wortley,

all of which are at present wholly included in the Rural District of Wortley;

- (19) the Parish of Beighton,
- (20) the Township of Coal Aston,
- (21) the Parish of Dronfield Woodhouse.
