1920, hereinafter referred to as the principal Order, shall apply only to the Prohibited Area described in the Second Schedule to the Gloucestershire and District (Foot-and-Mouth Disease) Order of 1920 (No. 4), and that Area shall be the Scheduled District for the purposes of the principal Order, which shall apply thereto without modification except as authorised by the Gloucestershire and District (Footand-Mouth Disease) Order of 1920 (No. 2).

Commencement.

2. This Order shall come into operation on the fifteenth day of March, nineteen hundred and twenty.

Short Title.

3. This Order may be cited as THE GLOUCES-TERSHIRE AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1920 (No. 6) and shall be read with the principal Order.

OXFORDSHIRE AND DISTRICT (FOOT-AND MOUTH DISEASE) ORDER OF 1920 (No. 5).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

Modification of Orders.

1. The Oxfordshire and District (Foot-and-Mouth Disease) Order of 1920, and the Oxfordshire and District (Foot-and-Mouth Disease) Orders of 1920 (Nos. 2 to 4), all of which are hereinafter referred to as "the existing Orders," are modified in the manner hereinafter contained.

Contraction of Scheduled District and of Prohibited Area.

2. The existing Orders shall be read and have effect as if the Area described in the First Schedule to the Oxfordshire and District

(Foot-and-Louth Disease) Order of 1920 (No. 4) were the Scheduled District for the purposes of those Orders, and as if the three Areas described in the Schedule to this Order were Prohibited Areas for those purposes.

Commencement.

3. This Order shall come into operation on the fifteenth day of March, nineteen hundred and twenty.

Short Title.

4. This Order may be cited as the OxFORD-SHIRE AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1920 (No. 5), and shall be read with the existing Orders.

The parishes of Great Missenden, Monks Risborough, Great and Little Kimble, Great and Little Hampden, Ellesborough, Stoke Mandeville, Weston Turville, Wendover, Lee, Halton, and Aston Clinton.

2. An Area comprising: ----

In the administrative county of Oxford.

The parishes of North Aston, Middle Aston, Steeple Aston, Souldern, Fritwell, Somerton, Upper Heyford, Lower Heyford, Middleton Stoney, Ardley, Stoke Lyne, Fringford, Stratton Audley, Caversfield, Bucknell, Bicester Kings End, Launton, Bicester Market End, Chesterton and its detached part, Weston on the Green, Charlton on Otmoor, Wendlebury, Merton, Fencott and Murcott, Ambrosden, Arncott, Blackthorn, and Piddington; and

In the administrative county of Buckingham.

The parishes of Marsh Gibbon, Edgcott, Grendon Underwood, Woodham, Kingswood, Ludgershall and Wotton Underwood (except such portions as lie to the south and south-east of the road from Dorton to Wotton Station), and so much of the parish of Brill as lies to the north of the road running from Wotton Underwood via Thame Lodge, Rids Hill, and Springfield Farm to Muswell Hill.

3. An Area in the administrative counties of Oxford and Buckingham.

Comprising the parishes of Shabbington and Albury, and portions of the parishes of Chilworth Ickford, Waterstock, Teddington, Great Haseley, and Thame, and lying within the following boundary, namely:—

Commencing at the Three Pigeons Inn in Ryecote Lane, south of Albury Village, thence in a north-easterly direction along that lane to its junction with the road leading from
