MINIMUM RATES OF WAGES (AS FIXED) FOR FEMALE WORKERS.

Effective as from 19th April. 1920.* In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated October, 1918, the Trade Board established under the Trade Boards Act, 1918, for that branch of the trade specified in the Trade Boards (Women's Clothing) Order, 1919, which is covered by the Regulations made by the Minister of Labour and dated 20th November, 1919, with respect to the Wholesale Mantle and Costume Trade Board in Great Britain, having given due notice on 12th January, 1920, of Proposal to Fix General Minimum Time-Rates, Piece-Work Basis Time-Rates and Overtime Rates for Female Workers, hereby give notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they have fixed General Minimum Time-Rates, Piece-work Basis Time-Rates and Overtime Rates for Female Workers, and have declared the normal number of hours of work in the trade for the purpose of the application of the Overtime Rates, and that the Minimum Rates of Wages as fixed are as set out below.
