ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED STH JULY 1920.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows :-

Authorisation of Landing of Animal for. Exceptional Purposes.

1. The landing of the animal described in the First Schedule hereto, which is intended for exceptional purposes, is hereby allowed, subject to the Provisions of Part II. (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and of the Foreign Animals (Quarantine) Order of 1896, and of this Order.

Definition of Quarantine Station.

2. The premises described in the Second Schedule hereto are hereby defined as a Foreign Animals Quarantine Station for the purpose of the landing and detention of the animal described in the First Schedule hereto.

Regulations applicable to the Animal on Landing.

3. The animal on being landed shall forthwith be moved, under the supervision of an Inspector of the Ministry of Agriculture and Fisheries, and confined in a suitable crate or box from the quay to the premises described in the Second Schedule hereto, and shall be there detained for a period of twenty-eight days, and during such period no other animal shall be moved into such premises.

One Wild Boar, the property of the Zoological Society of London, brought from France, and to be landed in the Port of Plymouth from the steamship "Mallard," on the ninth day of July, nineteen hundred and twenty.

A box at the Sanatorium situate near the South Entrance to the Gardens of the Society at Regent's Park, N.W., in the administrative county of London, and in the occupation of the Zoological Society of London.
