In accordance with Article 241 of the Treaty of Saint Germain-en-Laye of September 10th, 1919, notice was given to the Austrian Government on September 22nd, 1920, that the following bilateral treaties between the British Empire and Austria are revived from the date of this notice.

I.—*Extradition.*

(a) Treaty signed at Vienna on December 3rd, 1873, between the United Kingdom and Austria for the mutual surrender of fugitive criminals;

(b) Declaration signed at London on June 26th, 1901, amending Article 11 of the Treaty between the United Kingdom and Austria for the mutual surrender of fugitive criminals.

II.—*Money Orders.*

Arrangement between the Imperial and Royal Post Office of Austria and the Post Office of India signed at Calcutta, December 27th, 1905, and at Vienna, January 25th, 1906, for the exchange of Money Orders between Austria and India, including the modifications which came into force from April 1st, 1913, effected by exchange of Notes between the Indian and Austrian Postal administrations, ending with a letter from the Austrian Ministry of Commerce dated January 11th, 1913.

The use of the words "including the Austrian Post Offices establishment in Turkey" under Article 1, is contrary to the stipulation of the Treaty of Saint Germain-en-Laye. These words are therefore not included in the revival and must be regarded as excised from the Arrangement.
