

Universities of Oxford and Cambridge Act, 1877.

STATUTE to alter and amend the Statutes of Sidney Sussex College, in the University of Cambridge, which amending Statute was duly made at a Meeting of the Governing Body of the College specially summoned for this purpose and held on the sixth day of December, one thousand nine hundred and twenty, and having been passed at such meeting by the votes of more than two-thirds of the persons present and voting, is now submitted for the approval of His Majesty the King in Council.

We, the Master, Fellows and Scholars of the said College, in exercise of the powers given to us by the 54th Section of the Universities of Oxford and Cambridge Act, 1877, do hereby alter and amend the Statutes of our said College by repealing paragraph 2 of Chapter VIII of the said Statutes intituled "Of the Scholars" and substituting therefor the following paragraph to form an amended paragraph 2 of the said Statute:—

No one shall be allowed to compete for a Scholarship before commencing residence in the University if his age exceeds nineteen years on the first day of October preceding the examination. The maximum emolument of such entrance scholarship shall be one hundred pounds (£100) a year, and the tenure shall be for not more than two years certain.

AMENDMENTS, DATED 20TH DECEMBER, 1920, TO THE REGULATIONS MADE ON THE 2ND JANUARY, 1917, AND 30TH JUNE, 1917, UNDER SECTION 5 OF THE POLICE FACTORIES, & C. (MISCELLANEOUS PROVISIONS) ACT, 1916 (6 & 7 GEO. 5, C. 31), WITH REGARD TO STREET COLLECTIONS OF MONEY OR THE SALE OF ARTICLES FOR OTHER THAN TRADE PURPOSES.

By virtue of the powers conferred upon me by Section 5 of the Police, Factories, & C. (Miscellaneous Provisions) Act, 1916, I, being the Police Authority for the Metropolitan Police District, hereby make the following Amendments to the Regulations dated 2nd January, 1917, and 30th June, 1917, with respect to the places where and the conditions under which persons may be permitted in any street or public place within the Metropolitan Police District to collect money or sell articles for the benefit of charitable or other purposes:—

(a) At the end of Regulation No. (2), the following words shall be added:—"Provided that in the Commissioner's discretion
