the period of notice may be reduced in any particular case or class of cases if he is satisfied that there are special reasons for this course."

(b) At the end of Regulation No. (3) the following words shall be added:—" unless the Commissioner is satisfied that there are special reasons to the contrary."

(c) In Regulation No. (6), after the word "street" in the first place where that word occurs in the said Regulation, the following words shall be added:—"without special permission from the Commissioner."

(d) In Regulation No. (7), after the word "shall" in the first place where that word occurs in the said Regulation, the following words shall be added :-- "unless special exception is granted by the Commissioner."

I hereby confirm the foregoing Amendments, and direct that the same shall come into operation immediately upon their publication in the London Gazette.
