

run omnibuses on the following routes within their district, in addition to the routes mentioned in Section 4 of the said Act of 1917, viz. :—

Route No. 1.—From Piccadilly Square along the main road to Merthyr to the northern end of Llanbrach;

Route No. 2.—From the termination of Route No. 1 along the said main road to Ystrad Mynach and from thence to the boundary of the district at Nelson;

MELTON MOWBRAY.

Whereas the Urban District Council of Melton Mowbray have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, to partially repeal, alter, or amend the Melton Mowbray Cattle Market, &c., Act, 1869, so as:—

(1) To enable the Council to demand and receive in connection with their Cattle Market, tolls and rents in excess of the tolls and rents prescribed by the Schedule to the said local Act; and

ELECTRICITY COMMISSION. ELECTRICITY (SUPPLY) ACT, 1919. SOUTH-WEST MIDLANDS ELECTRICITY DISTRICT.

Whereas on the 20th September, 1920, the Electricity Commissioners published a Notice that they had provisionally determined that the area described in the said Notice shall be constituted a separate Electricity District for the purposes of the Electricity (Supply) Act, 1919:

And whereas it was provided by the said Notice that any objections or representations which might be made on account of the inclusion of any area in or the exclusion of any area from the District so provisionally determined should be made to the Secretary, Electricity Commission, Gwydyr House, Whitehall, London, S.W. 1, not later than the 31st day of January, 1921:

And whereas it was further provided in the said Notice that any authorised Undertaker, as defined in the Electricity (Supply) Act, 1919, any County Council, any Local Authority, any Railway Company using or proposing to use electricity for traction purposes, any large consumer of electricity and any association or body directly concerned with the production or use of electrical energy within the said District may, on or before the said 31st day of January, 1921, submit in writing a Scheme for effecting an improvement in the existing organisation for the supply of electricity in the said District, including the formation of a Joint Electricity Authority for the District and any proposals for altering or adjusting the boundaries of the District so provisionally determined:
