In pursuance of an Act for better preserving the Navigation of the River Mersey (5 and 6 Vic., cap. 110), We, the Mersey Power Company Limited, of Colonial House, Water Street, Liverpool, Public Electricity Supply Under-

taking, hereby give you notice that we propose to construct at Weston, in accordance with plans and sections deposited at the Office of the Mersey Conservancy, the Works described below, namely:—

To lay cables in the bed of the River Weaver near Weston Marsh Lock in the line shown on the site plan attached hereto for the purpose of conveying Electrical Energy from the Percival Lane Power Station of the Company at Run-corn to Ellesmere Port. Five cables are proposed in all—three power cables and two telephone cables. The cables will be paper insulated, lead sheathed and double wire armoured. They will be laid in a dredged trench in the bed of the river on a solid clay foundation. No interference with tidal waters is anticipated.
