BOOT AND SHOE REPAIRING TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY GENERAL MINIMUM PIECE RATES AND OVERTIME RATES FOR MALE AND FEMALE WORKERS.

The Boot and Shoe Repairing Trade Board (Great Britain) have issued a Notice of Proposal to Vary General Minimum Piece Rates for Male and Female Workers and Overtime Rates for Male and Female Workers employed on piece work to which General Minimum Piece Rates are applicable.

The variations in the General Minimum Piece Rates proposed in this Notice are directed mainly towards the removal of certain anomalies in the General Minimum Piece Rates at present fixed by the Trade Board. Certain amendments have also been made in the classification of the General Minimum Piece Rates.
