Definition of Irish Animals Landing Place.

2. All that space at the Port of Liverpool situate partly in the county borough of Birkenhead and partly in the county borough of Dirkon-head and partly in the county borough of Wallasey which is coloured pink on the plan (No. 34873) sealed by the Minister of Agriculture and Fisheries for the purposes of this Order, and deposited at the Ministry, is hereby defined as a Landing Place for Irish animals.

Definition of Foreign Animals Wharf.

3. All that space which is coloured blue on the plan referred to in Article 2 of this Order is hereby defined as a Foreign Animals Wharf for the purposes of the Diseases of Animals Acts, 1894 to 1914, and any Order of the Minister thereunder.

4. This Order may be cited as the LIVERPOOL (BIRKENHEAD) LANDING OF ANIMALS ORDER OF 1921 (No. 2).

NORFOLK AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1921 (No. 4).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:-

Further Contraction of Scheduled District.

1. The Norfolk and District (Foot-and-Mouth Disease) Order of 1921 shall apply only to the Area described in the Schedule to this Order, and that Area, subject to the modification contained in Article 2 of the first-mentioned Order, shall continue to be a Prohibited Area for the purposes of the Foot-and-Mouth Disease (Control of Movement) Order of 1920.

Commencement. .

2. This Order shall come into operation on the second day of May, nineteen hundred and twenty-one.

3. This Order may be cited as the NORFOLK

WILTSHIRE AND DISTRICT (MUZZLING AND CONTROL OF DOGS) ORDER OF 1921 (No. 5).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:

Withdrawal of Requirement of Leading in Inner Controlled Area.

1. Where under Article 2 (Control and Muzzling of Dogs in Inner Controlled Area) of the Wiltshire and District (Muzzling and Control of Dogs) Order of 1921 a dog is required to be efficiently muzzled with an effective wire cage muzzle, and also to be led by a person with a collar and chain or other attachment, it shall be deemed sufficient compliance with the provisions of that Article if the dog is efficiently muzzled with a wire cage muzzle without being also led.
