ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 2ND MAY 1921.)

CHESHIRE (FOOT-AND-MOUTH DISEASE) ORDER OF 1921 (No. 4).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

1. The Cheshire (Foot-and-Mouth Disease) Order of 1921 is modified in the manner hereinafter appearing.

2. The Scheduled District for the purposes of that Order shall be the district described in the First Schedule hereto.

3.—(i) The Area described in the Second Schedule hereto is hereby declared to be a Prohibited Area for the purposes of the Foot-and-Mouth Disease (Control of Movement) Order of 1920, hereinafter referred to as the "principal Order."

(ii) Part III of the principal Order shall apply to the Scheduled District.

(iii) The provisions of Article 2 of the Cheshire (Foot-and-Mouth Disease) Order of 1921 shall continue to apply to the Prohibited Area, and the provisions of Article 6 of the "principal Order" shall be read and have effect subject to this modification.

4. The Cheshire (Foot-and-Mouth Disease) Order of 1921 (No. 3) is hereby revoked.

5. This Order shall come into operation on the fourth day of May, nineteen hundred and twenty-one.

6. This Order may be cited as the CHESHIRE (FOOT-AND-MOUTH DISEASE) ORDER OF 1921 (No. 4), and shall be read with the Cheshire (Foot-and-Mouth Disease) Order of 1921.

FIRST SCHEDULE.

*Contracted Scheduled District.*

A district comprising the petty sessional division of Wirral, in the administrative county of Chester, and the county boroughs of Birkenhead and Wallasey.

SECOND SCHEDULE.

*Prohibited Area.*

An area comprising the parishes of Bromborough, Poulton-cum-Spital, Lower Bebington, Higher Bebington, Thornton Hough, Brimstage, Storeton, Prenton and Nocturum, in the administrative county of Chester; And also comprising  
The county borough of Birkenhead.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 2ND MAY 1921.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

*Authorisation of Landing of Animals for Exceptional Purposes.*

1. The landing of the animals described in the First Schedule hereto, which are intended for exceptional purposes, is hereby allowed, subject to the provisions of Part II (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and of the Foreign Animals (Quarantine) Order of 1896, and of this Order.

*Definition of Quarantine Station.*

2. The premises described in the Second Schedule hereto are hereby defined as a Foreign Animals Quarantine Station for the purpose of the landing and detention of the animals described in the First Schedule hereto.

*Regulations Applicable to the Animals on Landing.*

3. The animals on being landed shall forthwith be moved under the supervision of an Inspector of the Ministry of Agriculture and Fisheries from the quay to the premises described in the Second Schedule hereto, and shall be there detained for a period of twenty-eight days, and during such period no other animal shall be moved into such premises.
