## GAS REGULATION ACT, 1920.

Notice of Application by the Dunstable Gas and Water Company for an Order under Section 1 of the Gas Regulation Act, 1920.

OTICE is hereby given, that the Dunstable Gas and Water Company (hereinafter referred to as "the Undertakers") have applied to the Board of Trade under the provisions of Section 1 of the Gas Regulation Act, 1920, for an Order providing for:

(a) the repeal of any enactments or other provisions requiring the Undertakers to supply gas of any particular illuminating value, and the substitution therefor of power to charge for thermal units supplied in the

form of gas; and

(b) the modification of the statutory or other provisions affecting the charges which may be made by the Undertakers by substituting for the maximum prices per 1,000 cubic feet now authorised, with additions to meet increases in the costs and charges of and incidental to the production and supply of gas by the Undertakers since 30th June, 1914, maximum prices per therm (i.e., 100,000 British Thermal Units).

The maximum prices now authorised in respect of the supply of gas by the Undertakers are four shillings and twopence per thousand cubic feet for gas supplied to ordinary consumers within the borough of Dunstable, and five shillings and sixpence per thousand cubic feet for gas supplied to ordinary consumers elsewhere within the Undertakens' limits of supply, and three shillings and fourpence per thousand cubic feet, or the lowest price for the time being charged by the Undertakers for gas supplied to any private comsumer, for gas supplied to public lamps within fifty yards

of the Undertakers' mains.

The prices which the Undertakers have asked the Board of Trade to substitute for these prices in accordance with paragraph (b) above are 19d. per therm for gas supplied within the said borough, and 20.5d. per therm for gas supplied elsewhere within the Undertakers' limits of supply, and 17d per therm, or the lowest price for the time being charged by the Undertakers for gas supplied to any private consumer, for gas supplied to such public lamps as aforesaid.
