

aries of the Wards of the Borough, it shall be lawful for His Majesty, from time to time, by Order in Council, to fix the number of Wards into which the Borough shall be divided, and that the Borough shall be divided into that number of Wards, and that where an Order in Council has been so made the Secretary of State shall appoint a Commissioner to prepare a Scheme for determining the boundaries of the Wards and apportioning the Councillors among them:

And whereas a majority of the whole Council of the Borough of Luton did, on the 18th day of January, 1921, agree to petition, and the Council of the said Borough thereupon petitioned, His Majesty for the alteration of the number and boundaries of the Wards of the said Borough:

And whereas His Majesty was pleased, by His Order in Council of the 9th day of March, 1921, to fix the number of Wards into which the Borough of Luton should be henceforth divided, and to order and direct that the number of the said Wards should be six:

And whereas on the 30th day of March, 1921, the Right Honourable Edward Shortt, one of His Majesty's Principal Secretaries of State, did appoint Willoughby Jardine, Esquire, Barrister-at-Law, a Commissioner to prepare a Scheme for determining the boundaries of such Wards, and for apportioning the Councillors of the said Borough among such Wards:

And whereas by Section 30 (5) of The Municipal Corporations Act, 1882, it is provided that, in case of alteration of Wards, the Commissioner shall so apportion among the altered Wards the Councillors for those Wards as to provide for their continuing to represent as large a number as possible of their former constituents:

And whereas the said Commissioner has accordingly prepared the following Scheme, dated the 12th day of April, 1921:—

SCHEME FOR THE PURPOSE OF DETERMINING THE BOUNDARIES OF, AND APPORTIONING COUNCILLORS AMONG, THE WARDS OF THE BOROUGH OF LUTON.

i. Number of Wards:

By an Order of His Majesty in Council made in that behalf on the 9th day of March, 1921, the number of Wards of the said Borough was fixed at six.

iii. Boundaries of Wards:

1. CENTRAL WARD.

Boundaries.

The area enclosed and bounded by:—

- (1) A line along the middle of:—
- (a) Church Street from the bridge of the Great Northern Railway which crosses the southern end of Hitchin Road;
- (b) The portions of Park Square and Park Street lying between Church Street and George Street;
- (c) The portion of George Street (on the south side of the Corn Exchange) lying between Park Street and Castle Street;

- (d) Castle Street to Windsor Street;
- (e) Windsor Street, from Castle Street to Chapel Street;
- (f) Chapel Street (otherwise Farley Hill) from Windsor Street to Russell Street;
- (g) Russell Street;

(2) A line (continued from the west end of Russell Street) along the middle of a portion of a road to be constructed under the Luton Town Planning Scheme, and marked Town Planning Road No. 2 on the Town Planning Map, to the proposed junction of such road with Town Planning Road No. 1;

(3) A line continued northward from the proposed junction of the Town Planning Roads described in No. (2) last aforesaid proceeding along the fence dividing the houses numbered 63 and 65, on the south side of Ashburnham Road, thence across that road, and along the middle of Dale Road.

(4) A line across Dallow Road from the middle line of Dale Road to and thence along the fence or wall forming the boundary between the properties, in Dallow Road, of the Co-operative Wholesale Society, Limited, and Messrs. Henry Brown and Sons, to the northern-most rail of the main line of the Great Northern Railway and thence along such northern-most rail to the bridge of the Great Northern Railway which crosses Hitchin Road;

which area is delineated on the annexed Map, is coloured Brown, and thereon named "Central Ward."

2. ST. MARY'S WARD.

Boundaries.

The area enclosed and bounded by:—

(1) The Borough boundary commencing at the junction of Hitchin Road and Hart Lane, and terminating at the point in Trapps Lane at which the footpath from Park Road West emerges;

(2) A line along the middle of:—

- (a) The said footpath from Trapps Lane to the west end of Park Road West;
- (b) The western portion of Park Road West to New Town Street;
- (c) New Town Street;
- (d) Castle Street, from New Town Street to George Street;
- (e) The portion of George Street on the south side of the Corn Exchange, and the portions of Park Street and Park Square lying between Castle Street and Church Street;
- (f) Church Street;
- (g) Hitchin Road from Church Street to Hart Lane;

which area is delineated on the annexed Map, is coloured Green, and thereon named "St. Mary's Ward."

3. SOUTH WARD.

Boundaries.

The area enclosed and bounded by:—

(1) The Borough boundary commencing at the point in Trapps Lane at which the footpath from Park Road West emerges, and terminating at the point where the footpath from Farley Hill (west of Farley Farm) crosses such boundary;
