ORDER OF THE BOARD OF TRADE DATED 6TH MAY, 1921, MAKING A RULE UNDER THE ASSURANCE COMPANIES ACT, 1909.

The Board of Trade, in pursuance of the powers conferred upon them by Section 2 of the Assurance Companies Act, 1909, do hereby make the following Rule, supplemental to the Rules relating to Deposits by Assurance Companies under Section 2 of the said Act made on the 6th June, 1910, the 7th July, 1915, and 24th January, 1917, respectively.

Where any Company has made a deposit in pursuance of the Act which includes £5 per cent. National War Bonds due on or before 1st September, 1925, and the Company desires to convert such Bonds or any part thereof into £3 10s. per cent.
