ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

YORKSHIRE (WEST RIDING) (FOOT-AND-MOUTH DISEASE) ORDER OF 1921 (No. 2).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as

1.—(1) The Area described in the Schedule hereto is hereby declared to be a Prohibited Area for the purposes of the Foot-and-Mouth Disease (Control of Movement) Order of 1920, hereinafter referred to as the "principal Order."

(2) Part III. of that Order is hereby applied to the Scheduled District described in the Yorkshire (West Riding) (Foot-and-Mouth Disease) Order of 1921.

(3) The provisions of Article 2 of the Yorkshire (West Riding) (Foot-and-Mouth Disease) Order of 1921 shall continue to apply to the Prohibited Area, and the provisions of Article 6 of the "principal Order" shall be read and have effect subject to this modification.

2. This Order shall come into operation on the thirteenth day of May, nineteen hundred and twenty-one.

3. This Order may be cited as the YORK-SHIRE (WEST RIDING) (FOOT-AND-MOUTH DISEASE) ORDER OF 1921 (No. 2), and shall be read with the Yorkshire (West Riding) (Foot-and-Mouth Disease) Order of 1921.
