ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 18TH MAY 1921.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

1. The restrictions on movement of swine imposed by the Swine-Fever (Regulation of Movement) Order of 1908 and the Suffolk (Swine-Fever) Order of 1914 shall not apply to the movement of swine from the sale mentioned in the Schedule hereto to any premises in Great Britain not being a Swine-Fever Infected Place, if the swine are accompanied by a licence in the Form F set forth in the First Schedule to the said Order of 1908, granted by an Inspector of the Local Authority of the County of Suffolk, and the following conditions, which shall be specified in the licence, are complied with:—

(i) The swine shall be moved to the place of destination specified in the licence and not elsewhere, and shall be there detained and kept separate from all other swine for twenty-eight days, unless they are slaughtered on such premises before the expiration of that period, or are moved under and in accordance with the conditions of a licence in the Form C set forth in the said First Schedule to a bacon factory or slaughterhouse in the same Scheduled Area.

(ii) The swine shall be moved by the nearest available route without unnecessary delay, and during the movement shall, so far as is practicable, be kept separate from all swine not being moved with a licence under this Order.

(iii) After completion of the movement the licence shall forthwith be delivered up at, or sent by post to, the nearest policestation in the same district by the person in charge of the swine at the time of completing such movement.

2. A copy of a licence issued under this Order shall be sent by the Inspector granting the same to the Local Authority of the District in which the place of destination specified in the licence is situate.

3. A licence under this Order shall for the purposes of the above-mentioned Orders be treated as a licence under those Orders.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

Application of Sheep (Double Dipping) Order of 1920.

1. Part I. (Restriction on Movement of Sheep out of a Movement Area) and Part II. (Double Dipping of Sheep in a Double Dipping Area) of the Sheep (Double Dipping) Order of 1920, hereinafter referred to as "the Principal Order," are hereby applied to the Area described in the Schedule hereto, which shall be a Movement Area and a Double Dipping Area for the purposes of that Order.

Period Prescribed as Double Dipping Period.

2. The dates between which all sheep in the Area described in the Schedule hereto are to be dipped within the Area by the owner or person in charge of the sheep under and in accordance with Part II. of the Principal Order are hereby fixed to be the seventeenth day of November and the thirtieth day of December.

Commencement.

3. This Order shall come into operation on the first day of July, nineteen hundred and twenty-one.

Revocation.

4. The Order of the Minister dated the ninth day of July, nineteen hundred and twenty, relating to the area described in the Schedule hereto is hereby revoked.
