portions of the parishes of Thurstonland, Farnley Tyas and Honley, as lie within the following boundary, namely :--

Commencing at the point where the parish boundary crosses Longley Lane, near Longley Quarry, and proceeding in a westerly direction along Longley Lane to its junction with Moor Lane, thence in a south-westerly direction along Brock Holes Lane to the point where it crosses the Huddersfield and Penistone branch of the Lancs. and Yorks. Railway, thence in a southerly direction along that railway and the Holmfirth Branch of the same railway to the point where it crosses the road leading from Thurstonland to Scar End, thence in a southeasterly direction along that road to the point where it meets the Occupation Lane at Bank End Plantation, thence in a south-easterly direction along the Occupation Lane to its junction with Halstead Lane, near Hanging Royd Shrogg, thence in a north-easterly direction along Halstead Lane to the point where it meets Ing Head Lane, thence in a northerly direction along Ing Head Lane, Butts Lane, Brown's Knoll Lane and Broad Lane to Farnley Moor End, and thence in a westerly direction along Height Green Lane to the point of commencement.

# NORTH MIDLAND COUNTIES (FOOT-AND-MOUTH DISEASE) ORDER OF 1921.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:

#### Application of Order to Scheduled District.

1. Parts I, III and IV of the Foot-and-Mouth Disease (Control of Movement) Order of 1920, hereinafter referred to as "the principal Order," are hereby applied to the District described in the First Schedule hereto, which shall be a Scheduled District for the purposes of that Order.

## Prohibited Areas.

2. The several Areas described in the Second Schedule hereto are hereby declared to be Prohibited Areas for the purposes of the principal Order.

## Movement within Prohibited Areas.

3.-(1) Where an Inspector of the Ministry considers it necessary or expedient, after inquiry, that an animal in a Prohibited Area should be permitted to be moved within the same Prohibited Area as often as occasion may require between different parts of the same farm, he may, notwithstanding any prohibition of movement contained in the principal Order, authorise such movement by an Occupation Licence, and the Inspector may insert in the licence such conditions as he may consider necessary or desirable for the purpose of preventing the animals referred to in the licence from coming into contact with any other animals.

(2) If in respect of any animal the condi-tions of a licence granted under this Article are not complied with, the owner of the animal and the person for the time being in charge thereof shall each, according to and in respect of his own defaults, be deemed guilty of an offence against the Act of 1894.

# Movement into Borough of Buxton for Immediate Slaughter.

4. Part II of the Foot-and-Mouth Disease (Control of Movement) Order of 1920 is hereby applied to the borough of Buxton.

### Revocation.

5. The Orders described in the Third Schedule to this Order are hereby revoked.

#### Short Title.

6. This Order may be cited as the NORTH MIDLAND COUNTIES (FOOT-AND-MOUTH DISEASE) ORDER OF 1921.
