His Majesty the KING has directed that the Military Cross and the Bar to the Military Cross which were awarded to Lieutenant William Frederick Richmond, The East Lancashire Regiment, and gazetted on the 1st January, 1917, and 18th February, 1918, respectively, shall be cancelled and that his name shall be erased from the Register, in consequence of his having been cashiered by sentence of a Field General Court-Martial.

His Majesty the KING has directed that the award of the Military Cross to Lieutenant Ernest Bell, The South Staffordshire Regiment, which was gazetted on the 3rd March, 1917,

shall be cancelled, and his name erased from the Register in consequence of his having been removed from the Army.

His Majesty the KING has directed that the award of the Military Cross to Harold Wood Tregunna (late temporary Lieutenant (acting Captain), Service Battalions, The Royal Welch Fusiliers), which was gazetted on the 8th March, 1919, shall be cancelled, and his name erased from the Register in consequence of his having been convicted by the Civil Power.
