"And we, the said Archbishop, being on full consideration and enquiry satisfied with the said Scheme, do hereby pursuant to the said Pluralities Act certify the same and such Consents as aforesaid to Your Majesty in Council to the intent that Your Majesty in Council may in case Your Majesty in Council shall think fit so to do make and issue an Order for carrying the said Scheme into effect.
