Thomas, which, founded here by our pious churchmen, flourishes to-day in the great Houses opposite to the of institution Parliament.

We are glad of this occasion to declare our unswerving loyalty to your Throne, and we pray that a settled peace within the Empire and the World at large for many years to come may afford to your Majesties joy and happiness through a long and prosperous reign.
