

point where the fence which divides the close numbered 180 upon the said Ordnance Map of the Civil Parish of Fenton and upon the said Map or Plan which is annexed to this Scheme or Representation from the close numbered 183 upon the same maps meets the northern side of the premises attached to Pool Dole Farm, and extending thence northward along the said fence and along the fence which divides the said close numbered 180 from the close numbered 184 upon the said maps for a distance in all of  $6\frac{3}{4}$  chains or thereabouts to the point where the last mentioned fence meets the south-eastern side of the roadway leading from Myatts Lane to Greenhill Farm, and extending thence in a straight line due west (thereby crossing the last mentioned roadway and passing to the north of the houses at Fenton Park) for a distance of  $18\frac{1}{2}$  chains or thereabouts to the boundary which divides the said New Parish of Saint Jude, Hanley, from the said New Parish of Christ Church, Fenton.

" IV. Also all that portion of the said New Parish of Saint John the Baptist, Lane End, which is bounded upon the north-west partly by the said New Parish of Saint Jude, Hanley, and partly by the said New Parish of Christ Church, Fenton, upon the south-west by the said New Parish of Christ Church, Fenton, and upon the remaining sides, that is to say, upon the south, upon the south-east and upon the east, by an imaginary line commencing upon the boundary which divides the said New Parish of Christ Church, Fenton, from the said New Parish of Saint John the Baptist, Lane End, at the junction of King Street with Park Lane, and extending thence north-eastward along the middle of Park Lane for a distance of  $8\frac{1}{2}$  chains or thereabouts to the point opposite to the western end of the fence forming the south-western boundary of the close numbered 239 upon the said Ordnance Map of the Civil Parish of Fenton and upon the said Map or Plan which is annexed to this Scheme or Representation, and extending thence first south-eastward to the said fence and then first south-eastward and then north-eastward along such fence and along the fences forming the southern boundaries of the closes numbered 238 and 237 upon the said maps for a distance in all of 18 chains or thereabouts to the point where the fence forming the southern boundary of the said close numbered 237 meets the western side of the roadway leading from Brooksford Street to Park Road, and extending thence north-eastward in a straight line diagonally across the said roadway for a distance of 1 chain or thereabouts to the western end of the fence which divides the close numbered 256 upon the said maps from the close numbered 236 upon the same maps, and extending thence first eastward and then in various directions along the fences which divide the said close numbered 256 and the closes numbered 235, 214, 217, 218, 219 and 179 upon the said maps from the said close numbered 236 and the closes numbered 212, 215, 216 and 181 upon the same maps for a distance in all of 40 chains or thereabouts to the northern end of the fence which divides the said close numbered 179 from the said close numbered 181, upon the boundary which divides the said New Parish of Saint John the Baptist, Lane End, from the said New Parish of Saint Jude, Hanley.

" V. And also all that other portion of the

said New Parish of Saint John the Baptist, Lane End, which is bounded upon the south by the New Parish of Edensor, in the said County and Diocese, upon the west and upon the north by the said New Parish of Christ Church, Fenton, and upon the remaining side, that is to say, upon the east, by an imaginary line commencing upon the boundary which divides the said New Parish of Christ Church, Fenton, from the said New Parish of Saint John the Baptist, Lane End, at the point where Duke Street is joined by the roadway leading to the allotment gardens in the close numbered 304 upon the said Ordnance Map of the Civil Parish of Fenton and upon the said Map or Plan which is annexed to this Scheme or Representation, and extending thence first south-westward and then south-eastward along the middle of the said roadway for a distance of  $6\frac{1}{2}$  chains or thereabouts to the fence forming the north-western boundary of the said close numbered 304, and extending thence north-eastward along the said fence for a distance of 9 yards or thereabouts to the point where it meets the fence forming the eastern boundary of the same close, and extending thence southward along the last mentioned fence for a distance of 10 chains or thereabouts to the point where it reaches the northern side of Cockster Brook, and extending thence in a straight line due south to a point in the middle of the said brook upon the boundary which divides the said New Parish of Saint John the Baptist, Lane End, from the said New Parish of Edensor."

And whereas drafts of the said Scheme or Representation have been transmitted to the Patrons and to the Incumbents of the Cures affected by the arrangements which are contemplated by such Scheme or Representation and such Patrons and Incumbents have respectively signified their assent thereto:

And whereas the said Scheme or Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Lichfield.
