The KING's Most Excellent Majesty in Council.

**W**HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared, and laid before His Majesty in Council, a Scheme or Representation bearing date the 9th day of June, 1921, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme or Representation for altering the boundaries of the New Parish of Saint John the Baptist, Leeming, in the County of York and in the Diocese of Ripon:

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the 31st day of July, 1880, and published in the London Gazette on the 3rd day of the following month, part of the Parish of Burneston, in the said County of York and in the said Diocese of Ripon, was assigned as a District Chapelry to the consecrated Church of Saint John the Baptist, situate in the ancient Chapelry of Leeming, within the limits of the said Parish of Burneston, and the said District Chapelry was named 'the District Chapelry of Saint John the Baptist, Leeming':

"And whereas the said District Chapelry of Saint John the Baptist, Leeming, has under the provisions of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, become a New Parish of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above-mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said New Parish of Saint John the Baptist, Leeming, should be altered in the manner which is hereinafter mentioned:

"Now, therefore, with the consent of the Right Reverend Thomas Banks, Bishop of Ripon (in testimony whereof he has signed and
