ORDER OF THE MINISTER OF
AGRICULTURE AND FISHERIES.

(DATED 5TH JULY 1921.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

Application of Part I. of Sheep (Double Dipping) Order of 1920.

1.—(1) Part I. (*Restriction on Movement of Sheep out of a Movement Area*) of the Sheep (Double Dipping) Order of 1920, hereinafter referred to as "the principal Order," is hereby applied to the Area described in the Schedule hereto, which shall be a Movement Area for the purposes of that Order.

(2) This article shall come into operation on the twenty-sixth day of August, nineteen hundred and twenty-one, and shall cease to operate on the first day of October, nineteen hundred and twenty-one.

Application of Part II. of Sheep (Double Dipping) Order of 1920.

2.—Part II. (*Double Dipping of Sheep in a Double Dipping Area*) of the principal Order is also hereby applied to the Area described in the Schedule hereto, which shall be a Double Dipping Area for the purposes of that Order.
