#### SCHEDULE.

An Area comprising:—

*In the administrative county of Merioneth.*

Such portions of the parishes of Llangar and Llandrillo as lie to the east of the road running from Corwen via Cynwyd, Llandrillo and Blaen-y-cwm to its junction with the road running from Bala to Llangynog;

*In the administrative county of Montgomery.*

Such portions of the parishes of Llangynog, Llanrhaidr-ym-Mochnant, and Pennant as lie to the north, north-east and north-west of the road running from Bala via Llangynog, Penybont Fawr, to the village of Llanrhaidr-ym-Mochnant; and

*In the administrative county of Denbigh.*

Such portions of the parishes of Llanrhaidr-ym-Mochnant, Llanarmon Mynydd Mawr, Llansilin, and Llanarmon Dyffryn Ceiriog as lie to the north-west of the road running from Penybont Fawr through the village of Llanrhaidr-ym-Mochnant via Llidiart and Cae Hir to the village of Llanarmon Dyffryn Ceiriog, but excluding that portion of the parish of Llanarmon Dyffryn Ceiriog which lies to the north and north-east of the River Ceiriog.

#### ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 5TH JULY 1921.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

*Application of Part I. of Sheep (Double Dipping) Order of 1920.*

1.—(1) Part I. (*Restriction on Movement of Sheep out of a Movement Area*) of the Sheep (Double Dipping) Order of 1920, hereinafter referred to as "the principal Order," is hereby applied to the Area described in the Schedule hereto, which shall be a Movement Area for the purposes of that Order.

(2) This article shall come into operation on the eighth day of August, nineteen hundred and twenty-one, and shall cease to operate on the sixteenth day of September, nineteen hundred and twenty-one.

*Application of Part II. of Sheep (Double Dipping) Order of 1920.*

2.—Part II. (*Double Dipping of Sheep in a*

*Double Dipping Area*) of the principal Order is also hereby applied to the Area described in the Schedule hereto, which shall be a Double Dipping Area for the purposes of that Order.

*Period Prescribed as Double Dipping Period.*

3. The dates between which all sheep in the Area described in the Schedule hereto are to be dipped within the Area by the owner or person in charge of the sheep under and in accordance with Part II. of the principal Order are hereby fixed to be the fifteenth day of August and the sixteenth day of September, nineteen hundred and twenty-one.

#### SHEEP-DIPPING (BLACK MOUNTAIN DISTRICT) ORDER OF 1921.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

*Application of Part I of Sheep (Double Dipping) Order of 1920.*

1.—(1) Part I (*Restriction on Movement of Sheep out of a Movement Area*) of the Sheep (Double Dipping) Order of 1920, hereinafter referred to as "the Principal Order," is hereby applied to the Area described in the First Schedule hereto, which shall be a Movement Area for the purposes of that Order.

(2) This Article shall come into operation on the tenth day of August, nineteen hundred and twenty-one, and shall cease to operate on the tenth day of September, nineteen hundred and twenty-one.
