Ascension, Kinsley, situate as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings and burials should be paid and belong to the minister of the same church for the time being.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall

seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of the Ascension,

Kinsley, being:-

"All that part of the Parish of Hemsworth, in the County of York and in the Diocese of York, which is bounded upon the south west by the Parish of Felkirk, upon the west by the New Parish of Saint James, Ryhill, upon the north west by the Extra-Parochial Place or Liberty known as Nostell, upon the north east partly by the Parish of Wragby and partly by the Parish of Ackworth, all in the said County and Diocese, and upon the remaining side, that is to say upon the south east, by an imaginary line commencing upon the boundary which divides the said Parish of Ackworth from the said Parish of Hemsworth at or near the western end of the Bridge or culvert which carries Hoyle Mill Road across the stream flowing through Bingley Spring Wood, and extending thence first south westward and then in various directions along the middle of the said stream for a distance of half a mile or thereabouts to the centre of the bridge or culvert which carries the occupation road leading from Kinsley Common Farm to Hoyle Mill Road across the said stream, and extending thence south eastward along the middle of the said occupation road for a distance of 51 chains or thereabouts to its junction with Hoyle Mill Road, and extending thence south westward. along the middle of Hoyle Mill Road (thereby passing under the West Riding and Grimsby Line of the Great Northern and Great Central Railway) for a distance of 14 chains or thereabouts to a point opposite to the middle of the stream which flows to Hoyle Mill Dam at the point where such stream diverges from the southern side of Hoyle Mill Road, and extending thence south eastward to and along the middle of such stream for a distance of 13 chains or thereabouts to its junction with the stream which rises near Hollins Bank Wood, and extending thence first south eastward and then in various directions along the middle of the last mentioned stream for a distance of 23 chains or thereabouts to its source near the northern side of Hollins Bank Wood, and extending thence in a straight line due south for a distance of 30 yards or thereabouts to the fence forming the northern boundary of Hollins Bank Wood, and extending thence south westward along the said. fence for a distance of 6 yards or thereabouts to the point where it meets the fence on the eastern side of Wakefield Road, and extending thence first westward to and then north westward along the middle of Wakefield Road for a distance in all of 11½ chains or thereabouts to a point opposite to the eastern end of the fence forming the southern boundary of the close numbered 272 upon the Ordnance Map of the Civil Parish of Hemsworth published in the

year 1919 upon the scale of 25 inches to a mile and also upon the map or plan which is annexed to this Scheme or Representation, and extending thence first south westward to the said fence and then first south westward, then north westward, and then again south westward along such fence and along the fences forming the south eastern boundaries of the closes numbered 596, 594 and 591 upon the said maps for a distance in all of 36 chains or thereabouts to the point where the last-mentioned fence crosses the stream flowing through Chantry Wood, and extending thence first south westward and then in various directions along the middle of the last-mentioned stream (thereby passing last-mentioned through Chantry Wood) for a distance of 44 chains or thereabouts to the boundary which divides the said Parish of Hemsworth from the said Parish of Felkirk."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of York.
