the 26th day of January, 1917, the 15th day of July, 1918, and the 21st day of May, 1919, issued by the Local Government Board, and of an Order dated the 10th day of March, 1920, issued by the Minister of Health under Section 1 of the Special Acts (Extension of Time) Act, 1915 (hereinafter referred to as "the Act of 1915"), the time limited for the exercise by the Mayor, Aldermen and Burgesses of the Borough of Chesterfield (hereinafter referred to as "the Corporation") of their powers for the compulsory purchase of lands required for the purposes of the Act of 1914 expired, in the case of lands required for or in connection with certain Works authorised by that Act, on the 8th day of July, 1921;

And whereas in pursuance of Section 1 of the Act of 1915 the Corporation applied to the Minister of Transport, before the expiration of the times limited as aforesaid, for an Order further extending those times:

Now, therefore, the Minister of Transport, in pursuance of the powers given to him by Section 1 of the Act of 1915, and of any other powers in that behalf, hereby extends until the 8th day of July, 1922, the times limited as aforesaid for the exercise of the powers of the Corporation—

- (a) for the compulsory purchase of the lands required for or in connection with the Works Nos. 2, 5, 6, 7, 9, 11, 14, 15, 17, 21 and 24; and
- (b) for the completion of Works Nos. 1, 2, 5, 6, 7, 9, 11, 14, 15, 17, 20, 21, 23, 24 and 25.
