NOTICE.

In pursuance of Section 6 of the Housing Act, 1921, which provides—

(1) That Section 40 of the Housing, Town Planning, etc., Act, 1919 (which defines a Public Utility Society), shall have effect as though the words "the issue of any share or loan capital with interest or dividend exceeding the rate for the time being prescribed by the Treasury" were substituted for the words "the payment of any interest or dividend at a rate exceeding six per cent. per annum."

(2) That Section 10 of the Housing (Additional Powers) Act, 1919 (which authorises the acquisition of land for the purposes of garden cities or town planning schemes) shall have effect as though in the definition of "authorised association" in sub-section (4) thereof the words to be substituted as afore-said were substituted for the words "payment of any interest or dividend at a higher rate than six per centum per annum,"

And in pursuance of Section 10 of the Housing Act, 1921, which provides that the Act in its application to Ireland shall have effect as though references to Section 40 of the Housing, Town Planning, etc., Act shall be construed as references to Section 33 of the Housing (Ireland) Act, 1919,

The Lords Commissioners of His Majesty's Treasury hereby give notice that, for the purpose of the said Section 40 of the Housing, Town Planning, etc., Act, 1919, and Section 33 of the Housing (Ireland) Act, 1919, as amended by the said Section 6 of the Housing Act, 1921, the prescribed rate shall for the time being be the rate of six and one-half per cent. per annum, and that for the purpose of the said Section 10 of the Housing (Additional Powers) Act, 1919, as amended by the said Section 6 of the Housing Act, 1921, the prescribed rate shall for the time being be the rate of seven per cent. per annum.
