· PART III.

PROPOSED VARIATION OF OVERTIME RATES FOR FEMALE WORKERS (ALL AGES).

Overtime Rates calculated on the Proposed Minimum Rates of Wages specified in Parts I and II of this Schedule in the manner set out in Part III or the Schedule to the Trade Board's Notice U (6) dated 10th September, 1921, shall apply in substitution for the Proposed Minimum Rates of Wages specified in Parts I and II of this Schedule in respect of all hours worked by a Worker, whether employed on Time-work or on Piece-work, in excess of the number of hours declared by the Trade Board in the Schedule to the above-mentioned Notice dated 10th September, 1921, to be the normal number of hours of work in the Trade.

PART IV.

The Proposed Mirimum Rates of Wages for Female Workers set out in Parts I, II, and III of this Schedule shall apply, subject to the provisions of the Trade Boards Act, to all Female Workers in Great Britain in respect of all time during which they are employed in any branch of the trade specified in the Trade Boards (Coffin Furniture and Cerement-Making) Order, 1919, as set out in Part IV. of the Schedule to the Trade Board's Notice U (6), dated 10th September, 1921.

The above Proposed General Minimum Time-Rates, Piec work Basis Time-rates and Overtime

Rates are without prejudice to workers who are earning higher rates of wages, or to agreements made, or that may be made between employers and workers for the payment of wages in excess of these Minimum Rates of Wages.

The Trade Board will consider any Objections to the above Proposals which may be lodged with them within two months from the 23rd November, 1921. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to The Secretary of the Coffin Furniture and Cerement Making Trade Board (Great Britain), 7-11, Old Bailey, London, E.C. 4.

It is desirable that the Objections should state precisely, and so far as possible with reasons,

what is objected to.
