Wrotham, Hildenborough and Leigh as lie easterly direction along St. Botolph's Road, Dartford Road, Park Lane and Seal Seal Hollow Road to Blackhall Lane, thence along that lane to Hall Cottage, thence continuing along the footpath to Hanger Wood, and thence along the road following the south side of that wood via Blakes Green, Stone Street and Ivy Hatch to High Cross, thence in a southerly direction along the road from High Cross via Shipbourne and Hoad Common to the point where it is crossed by the boundary of the parish of Hildenborough near Dene Park Farm, thence in a southerly direction along that parish boundary to Frog Bridge, thence in a southerly direction along the road from Frog Bridge to Little Trench to the point where it is again crossed by the boundary of the parish of Hildenborough. thence in a generally south-westerly direction along that boundary to the South Eastern and Chatham Railway line, thence along the northern side of that line in a north-westerly direction to the road leading from Oak Lodge to Stocks Green, thence westerly along that road via Stocks Green, Lower Street and the Blue Anchor Beer House to the point where it meets the road leading to Sevenoaks Weald via the Priory, thence northerly along the last mentioned road via the Priory and Hubbards Hill to the boundary of the parish of Seven-oaks, thence westerly, northerly and easterly along that boundary to the point of commencement.

KENT (SEVENOAKS DISTRICT) (FOOT-AND-MOUTH DISEASE) ORDER OF 1921 (No. 5).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:

Contraction of Prohibited Area.

1. The Kent (Sevenoaks District) (Foot-and-Mouth Disease) Order of 1921 (No. 4) shall be read and have effect as if the area described in the Schedule hereto were excluded from, and ceased to form part of, the Prohibited Area to which that Order applies.

2. This Order shall come into operation on the thirteenth day of December, nineteen hundred and twenty-one.

3. This Order may be cited as the KENT (SEVENOAKS DISTRICT) (FOOT - AND - MOUTH DISEASE) ORDER OF 1921 (No. 5), and shall be read with the Kent (Sevenoaks District) (Foot-and-Mouth Disease) Order of 1921 (No. 4).
