BIRMINGHAM CORPORATION.

(Further Provisions as to Retirement and Pensions of Fire Brigade and application of Police Pensions Act, 1921.)

NOTICE is hereby given, that the Lord Mayor, Aldermen and Citizens of the City of Birmingham (hereinafter called "the Corporation") intend to include in the Bill to be promoted by the Corporation in the ensuing Session (in addition to the objects of which notice was given in, inter alia, the London Gazette on the 22nd November, 1921, and in the Birmingham Gazette on the 19th and 26th November, 1921) provisions for effecting the following purposes, namely:—

1. To make provision that as from such date as may be determined by the Corporation or enacted in the intended Act, the provisions relating to the retirement of and the payment of pensions to the members of the permanent Fire Brigade of the city (hereinafter called "the Fire Brigade") shall, so far as practicable, be brought into harmony with the provisions relating to the retirement of and the payment of

pensions to members of the Police Force of the city.

2. To extend to the members of the Fire Brigade such of the provisions of the Police Pensions Act, 1921, as may be applicable, subject to the modifications indicated in the intended Act.

3. To continue the Fire Brigade Pension Fund and to make provision for the payments into and out of that fund, the investment and use thereof and the making good of deficiencies.

4. To alter, amend or repeal provisions relating to the Fire Brigade contained in the Birmingham Corporation Acts, 1914 and 1919.

Printed copies of the intended Act or Bill will be deposited in the Private Bill Office of the House of Commons on the 17th day of December instant, and will contain provisions to the foregoing effect.
