NATIONAL HEALTH INSURANCE ACTS, 1911 to 1921.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee, acting jointly with the Minister of Health, the Scottish Board of Health, and the Irish Insurance Commissioners, and with the consent of the Treasury, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by the National Health Insurance Acts, 1911 to 1921, and by the National Insurance (Joint Committee) Regulations, 1912 to 1920, to make regulations prescribing the sum to be paid to insurance committees on account of the administration expenses of those committees in respect of each of the total number of persons entitled to medical benefit, or, in Ireland, sanatorium benefit, as being or having been members of an approved society, and amending the National Health Insurance (Approved Societies) Consolidated Regulations, 1918 to 1920.

FOOT-AND-MOUTH DISEASE:
INFECTED PLACE.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

The premises mentioned in the Schedule hereto are hereby declared to be a place infected with Foot-and-Mouth Disease.
