The following Statute made by the University of Oxford, on the 21st day of February, 1922, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1877":—

UNIVERSITY OF OXFORD.

STATUTE APPROVED BY CONVOCATION ON TUESDAY, FEBRUARY 21, 1922.

Whereas it is expedient to amend clause 7 of Sectio XII. § 2 of Titulus V. of the Statutes of the University of Oxford, by substituting for the words "the tenth day" mentioned in that clause the words "the twelfth day":

Now the said University, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1877, and of all other powers enabling it, enacts subject to the approval of His Majesty in Council as follows:—

In Statt. Tit. V. Sect. XII. § 2. cl. 7 (University Gazette, November 23, 1921, p. 191), the words "the tenth day" shall be struck out, and the words "the twelfth day" shall be substituted for them.
