Branch Line of the London and South Western Railway, and extending thence north westward along the middle of the said line of railway for a distance of 1<sup>1</sup>/<sub>2</sub> chains or thereabouts to the centre of Willingcott Bridge, which carries the road leading from Willingcott Cross to Roadway Corner across the said line of railway, and extending thence first southward, then north westward and then south westward along the middle of the said road for a distance of  $13\frac{1}{2}$ chains or thereabouts to its junction with the roadway leading past the farmhouse known as Oussaborough into Woolacombe Station Road, and extending thence first northward and then in various directions along the middle of the said roadway for a distance of 31 chains or thereabouts to its junction with Woolacombe Station Road, and extending thence first north westward and then north eastward along the middle of Woolacombe Station Road for a distance of  $9\frac{1}{2}$  chains or thereabouts to a point opposite to the eastern end of the fence which divides the close numbered 245 upon the Ordnance Map of the Civil Parish of Morthoe published in the year 1904 upon the scale of 25 inches to a mile and also upon the map or plan which is annexed to this Representation from the close numbered 205 upon the said maps, and extending thence first westward to the said fence and then first westward and then in various directions along the fences which divide the said close numbered 245 and the closes numbered 244, 243, and 264 upon the said maps from the said close numbered 205 and the closes numbered 206, 241, 242, and 238 upon the same maps for a distance of 28 chains or thereabouts to the point where the fence which divides the said close numbered 264 from the said close numbered 238 crosses the middle of the roadway leading from Eastacott Lane to the road which leads from Morthoe Station to Morthoe, and extending thence northward along the middle of the last-mentioned roadway for a distance of fifteen chains or thereabouts to a point opposite to the eastern end of the fence which divides the close numbered 305 upon the said maps from the close numbered 265 upon the same maps, and extending thence first westward to the said fence and then first westward and then in various directions along the fences which divide the said close numbered 305 and the closes numbered 280 and 278 upon the said maps from the said close numbered 265 and the closes numbered 267, 279, 270, 273, and 277 upon the same maps for a distance of 331 chains or thereabouts to the point where the fence which divides the said close numbered 278 from the said close numbered 277 meets the southern side of Sandy Lane, and extending thence first northward to and then westward along the middle of Sandy Lane for a distance of 194 chains or thereabouts to a point opposite to the eastern end of the fence which divides the close numbered 341 upon the said maps from the close numbered 486 upon the same maps, and extending thence first north westward to the last-mentioned fence and then first north westward and then in various directions along the fences which divide the said close numbered 341 and the closes numbered 475, 467, 466, 465, 464, and 479 upon the said maps from the said close numbered 486, and the closes numbered 485, 484, 482, and 480 upon the same maps for a distance of  $57\frac{1}{2}$  chains or thereabouts to the point where the fence which divides the said close numbered 479 from the said close numbered 480 meets the eastern side of Parade Road, and extending thence first westward to the middle of Parade Road and then south westward along the middle of such road for a distance in all of 3 chains or thereabouts to a point opposite to the middle of the path leading to Combegate Beach, and extending thence in a straight line due west to the Sea."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Exeter.

W HEREAS the Minister of Health, after giving to the Incumbent and the Churchwardens of the Parish of Saint Paul's, Fisherton Anger, Salisbury, in the County of Wilts, 10 days' previous Notice of his intention in that behalf, has, under the provisions of the Burial Act, 1853, as amended by subsequent enactments, made a Representation to His Majesty in Council that, for the protection of the public health, the opening of any new Burial Ground in the Civil Parish of New 'Sarum (or Salisbury), in the said County of Wilts, save with the previous approval of the Minister of Health, should be prohibited, and that Burials should be discontinued therein, as follows, viz.:—

SALISBURY.—Forthwith and entirely in the Parish Church of Saint Paul's, Fisherton Anger, Salisbury, and in the Churchyard attached thereto.

Now, therefore, His Majesty in Council is pleased hereby to give Notice of such Representation, and to order that the same be taken into consideration by a Committee of the Privy Council on the 30th day of May next.

And His Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within, the Parish affected by such Representation one month before the said 30th day of May.
