West of Gheluwe, on the 1st October, 1918, during the attack on Gheluwe Village, this non-commissioned officer displayed conspicuous gallantry and devotion whilst commanding a sub-section of machine guns. In the face of heavy hostile machine-gun and artillery fire he led his guns forward in support of the infantry and brought them into action with good effect, doing much to assist the infantry in their advance. Later, when the right flank of the infantry were suffering from machine-gun and rifle fire, he skilfully brought a gun into action, protecting the exposed flank, and reducing the hostile fire to a Throughout the operations he minimum. did much to inspire the men of his gun teams.
