- 10. Judges, Law Officers, King's Counsel, and all Legal Officials holding appointments under the Crown, other than those already mentioned, will similarly make their applications through the Private Secretary to the Lord Chancellor.
- 11. All gentlemen connected with the Foreign Office or any other Government Department will adopt the same procedure, and will communicate with and obtain their cards for attendance or presentation from the Department under which they serve.
- 12. The names both for attendance and presentation must be received at the various Offices above indicated not later than ten days prior to the date of the Levée.
