NATIONAL HEALTH INSURANCE ACTS, 1911 to 1921.

Notice is hereby given, under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by Section 3 (4) of the National Health Insurance Act, 1918, to make regulations providing for parts of the balances of the contingencies funds of small societies in Northern Ireland which are not required for making good deficiencies in those societies, to be applied towards making good the balances of the deficiencies remaining in the case of other small societies in Northern Ireland.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—
