MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS.

This Notice sets out the Minimum Rates of Wages for Male and Female Workers as varied by the Trade Board and confirmed by an Order of the Minister of Labeur, dated 10th July, 1922, together with the Minimum Rates (as set out in the Schedule to the Trade Board's Notice C.W. (8), dated 31st March, 1922) which are not affected by the variation and which remain in operation.

The Minimum Rates of Wages set out in the Schedule below are effective as follows:-

- (1) The General Minimum Time Rates marked † and the Overtime Rates based thereon as from 1st April, 1922.
- (2) All the other Minimum Rates as from 17th July, 1922.*

* Note.—Should this date not correspond with the beginning of the period for which wages are paid by any employer who pays wages at intervals not exceeding seven days, the rates become effective as from the beginning of the next full pay period, but in any case not later than 23rd July, 1922.

PART II.

OVERTIME RATES FOR MALE AND FEMALE WORKERS.

SECTION I.—In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board have declared the normal number of hours of work per week in the trade to be 48.

Provided that all hours worked on Sundays shall be regarded as Overtime to which the Overtime Rates shall apply.

SECTION II.—The minimum rates for Overtime in respect of hours worked by a worker in excess of the declared normal number of hours of work in the trade shall be as follows:---

- (a) For the first two hours of Overtime in any week (excluding all hours worked on Sundays), the Overtime Rate shall be ONE-AND-A-QUARTER times the minimum rate otherwise applicable, i.e., TIME-AND-A-QUARTER.
- (b) For overtime after the first two hours of overtime in any week (excluding all hours worked on Sundays), the Overtime Rateshall be ONE-AND-A-HALF times the minimum rate otherwise applicable, i.e., TIME-AND-A-HALF.
