## NURSES REGISTRATION ACT, 1919.

Whereas by Section 2 of the Nurses Registration Act, 1919, provision is made for the formation of a register of nurses for the sick and by sub-section (1) of Section 8 of the said Act it is enacted that any person who, not being a person duly registered under that Act, at any time after the expiration of three months from the date on which the Minister of Health gives public notice that a register of nurses has been compiled under the Act, takes or uses the name or title of a registered nurse or does any other of the acts referred to in paragraphs (a) and (b) of that sub-section shall be liable to the penalties therein mentioned:

Now, therefore, the Minister of Health, in pursuance of sub-section (1) of Section 8 aforesaid, hereby gives public notice that a register of nurses has been compiled under the said Act.

## THE ROADS ACT, 1920.

## COUNTY OF MONTGOMERY.

Whereas by sub-section (4) of Section 7 of the Roads Act, 1920, it is enacted that the Minister of Transport may, by Order on the application of any county council (as defined in Section 17 of the Act), after holding a public inquiry, prohibit or restrict, subject to such exceptions or conditions as to occasional user or otherwise as may be specified in the Order, the driving of mechanically-propelled vehicles of any specified class on any specified highway within the area of the council in any case in which it appears to him, as the result of the inquiry, to be proved that a vehicle of that class cannot be used on that highway without endangering the safety of the vehicle or the persons therein or of other traffic using the highway, or that the highway is unsuitable for use by a vehicle of that class;

And whereas the County Council of Montgomery have made application to the Minister of Transport for an Order to be made in pursuance of the said sub-section prohibiting or restricting, subject to such exceptions or conditions as to occasional user or otherwise as may be specified in the Order, the driving of heavy motor-cars and locomotives on the highways or portions of highways specified in the Sche-
