

"And whereas the said George Joscelyn L'Estrange, Earl of Carlisle, is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Lanercost with Kirkcambek should be transferred in the manner herein-after recommended and proposed:

"And whereas the Right Reverend Henry Herbert, now Bishop of Carlisle, in token of his willingness to accept jointly with the other persons hereinafter mentioned the transfer of the said Advowson or perpetual right of Patronage hereinafter recommended and proposed and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary, has executed the Scheme as herein-after mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Lanercost with Kirkcambek which is hereinbefore mentioned and hereinafter recommended and proposed will render the same Benefice more eligible for augmentation out of funds under our control, and this circumstance will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Lanercost with Kirkcambek:

"Now, therefore, with the consent of the said George Joscelyn L'Estrange, Earl of Carlisle, being the person whose consent as Patron is required by the provisions of the hereinbefore mentioned Acts, and of the Act of the 1st and 2nd years of Her said late Majesty, Chapter 106 (in testimony of which consent he the said George Joscelyn L'Estrange, Earl of Carlisle, has signed and sealed this Scheme), with the consent of the said Henry Herbert, Bishop of Carlisle (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), and with the consents of the persons to whom together with the said George Joscelyn L'Estrange, Earl of Carlisle, and the said Henry Herbert, Bishop of Carlisle, it is hereinafter recommended and proposed that the said Advowson and perpetual right of Patronage should be transferred, that is to say, with the consents of the Venerable Herbert Ernest Campbell, Clerk in Holy Orders and Archdeacon of Carlisle, of William James, of The Swarthe, Brampton, in the said County of Cumberland, Estate Agent, and of Joseph Laidler, of Northriggill, Lanercost, in the said County of Cumberland, Farmer (in testimony whereof they have signed and sealed this Scheme), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order, the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Lanercost with Kirkcambek shall be transferred to the said George Joscelyn L'Estrange, Earl of Carlisle, Henry Herbert, Bishop of Carlisle, Herbert Ernest Campbell, William James and Joseph Laidler and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said George Joscelyn L'Estrange, Earl of Car-

lisle, Henry Herbert, Bishop of Carlisle, Herbert Ernest Campbell, William James and Joseph Laidler, their heirs and assigns for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Carlisle.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Act, 1919, and the Union of Benefices Measure, 1921, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 23rd day of November, 1922, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Act, 1919, and the Union of Benefices Measure, 1921, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the union of two neighbouring Benefices that is to say the Benefice (being a Vicarage) of Norton Disney, and the Benefice (being a Rectory) of Thurlby (Saint Germain), both of which Benefices are situate in the County of Lincoln and in the Diocese of Lincoln:

"Whereas Commissioners appointed at our request by the Right Reverend William Shuckburgh, Bishop of Lincoln, pursuant to the provisions of the said Union of Benefices Act, 1919, to inquire into and report upon the union of the said two Benefices of Norton Disney and Thurlby (Saint Germain) duly made their Report to the said Bishop of Lincoln and therein recommended the union of the said two Benefices and the terms for effecting the union, and the said Bishop of Lincoln signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the union of the said two Benefices which Scheme is based upon the terms recommended in the said Report, but with the assent of the said Bishop of Lincoln embodies certain modifications thereof:

"And whereas both of the said Benefices of Norton Disney and Thurlby (Saint Germain) are at present vacant:
