- (i) The advances to be given to learners shall become due as from the first Monday in January and July of each year, the learner being entitled to her first advance as from the first Monday in January or July, as the case may be, provided that she has been in the trade at least three months.
- (ii) A learner shall cease to be a learner and be entitled to the full General Minimum Time-Rate applicable to her under Section I of this Part of this Schedule upon the fulfilment of the following conditions :—
