Now, therefore, I, Sylvanus Percival Vivian, Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836-1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Leominster Registration of Births, &c. (Alteration of Sub-districts), Order, 1923, and shall come into operation on the 1st January, 1923.

2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. The existing Leominster Sub-district of Leominster Registration District shall cease to exist and its constituent Civil Parishes shall be apportioned as follows:

(a) the Civil Parishes of Kimbolton, Laysters and Middleton on the Hill shall be transferred to the Kingsland Subdistrict of the same Registration District, and

(b) the Civil Parishes of Leominster Borough and Leominster Out shall be transferred to the Bodenham Sub-district of the same Registration District.

4. The Sub-district of Bodenham, as extended by this Order, shall be re-named Leominster Sub-district.

5. The Registrar of the existing Leominster Sub-district shall be the Registrar of the Leominster Sub-district as constituted by this Order and the Registrar of the existing Bodenham Sub-district shall be the Registrar of the Kingsland Sub-district as extended by this Order.

4. The Civil Parish of Hadlow Down shall be transferred from Maresfield Sub-district to Rotherfield Sub-district.

5. The Sub-district of Maresfield as altered by this Order shall be re-named Uckfield Sub-district.

6. The Registrar of the existing Maresfield Sub-district shall be the Registrar of the Uckfield Sub-district as constituted by this Order.
