PART V.

- SECTION I.-. The above Minimum Rates of Wages must be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.
- SECTION II.—The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages, or to agreements made or that may be made for the payment of wages in excess of the minimum rates.

Signed by Order of the Trade Board and in pursuance of Orders of the Minister of Labour dated 9th June, 1922, and 12th December, 1922, confirming the minimum rates as varied by the Trade Board and set out above and specifying the dates shown in this Notice as the dates from which they should become effective.
