to order, and it is hereby ordered, as follows:----

1. The Schedule to the County Courts Order in Council, 1904 (S.R. & O., 1904, No. 1784), as amended by the County Courts (Extended Jurisdiction) Order in Council, 1919 (S.R. & O., 1919, No. 2039), the County Courts (Extended Jurisdiction) Order in Council, 1920 (S.R. & O., 1920, No. 823), the County Courts (Extended Jurisdiction) Order in Council, 1921 (S.R. & O., 1921, No. 1800), and the County Courts (Extended Jurisdiction) Order in Council, 1922 (S.R. & O., 1922, No. 1351), shall be further amended as follows:—

(i) In Circuit 13, (a) Circuit No. 13 is removed from the first column of the said Schedule, (b) Sheffield is removed from the second column thereof, and (c) Rotherham is removed from the third column thereof.

2. This Order may be cited as the County Courts (Extended Jurisdiction) Order in Council, 1923, and shall come into operation on the 1st day of April, 1923, and the County Courts Order in Council, 1904, as amended, shall have effect as further amended by this Order.

# Ex parte the President and Fellows of St. John's College, in the University of Oxford.

A Statute made to amend certain Statutes framed by the Commissioners appointed under the Universities of Oxford and Cambridge Act, 1877 (40 and 41 Vict., c. 48), in relation to St. John's College, in the University of Oxford, duly passed at a General Meeting of the Governing Body of the said College specially summoned for this purpose on the 12th day of December, 1922, by the votes of the whole number of persons present and voting and submitted to His Majesty the King in Council.

Whereas in Statute XII. of the Statutes of the said College it is enacted: "Table Allowances. The President and Fellows may, if they think fit, set apart and allow a sum of money not exceeding three shillings a day in respect of the President and each Fellow, and also (if they think fit) of any Tutor or Lecturer not being a Fellow, for the expenses of his dinner on each day when he shall dine at the Common College dinner, whether in Hall, or in some public room of the College: "

And whereas it appears to us, the President and Fellows of the said College, that it is desirable that the said Statutes shall be altered and amended in manner hereinafter appearing:

Now we, the President and Fellows of the said College, in exercise of the powers vested in us under and by virtue of the 54th Section



of the Universities of Oxford and Cambridge Act, 1877, do, by this present instrument under our Seal, alter and amend the Statutes of the said College as hereinbefore set out in mauner following, that is to say:—

By substituting for the before-mentioned Statute XII. the undermentioned new Statute:—

"Table Allowances. The President and Fellows may allow from the Revenues of the College such moderate sums as the cost of food may from time to time render advisable for the expenses of their Common Table."
