APPOINTMENT OF STANDING FOR HACKNEY CARRIAGES WITHIN THE METROPOLITAN POLICE DIS-TRICT, AND REGULATIONS TO BE OBSERVED.

By virtue of the Act 13 and 14 Victoria, Chapter 7, intituled "An Act for Consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of Commissioners of Police of the Metropolis, and making other Provisions in regard to the Consolidated Offices,"

I, WILLIAM THOMAS FRANCIS HOR-WOOD, Commissioner of Police of the Metropolis, do hereby appoint a Standing for Ten Hackney Carriages at North End Road, Golders Green, and do make the following Regulations with regard to the boundaries for the same, viz.:

On north side of roadway, by kerb, commencing at a point immediately opposite shop door No. 2 same road, extending eastward as far as necessary for ten carriages.

Front of vehicles toward the west.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriageway, or upon any place where foot passengers usually cross the carriageway.
