

corner of the field numbered 359 on the Ordnance Survey Map Second Edition, 1898, for the said Parish and proceeding thence in a southerly direction along the western boundary of the said field until it reaches the centre of the lane leading from the cottages at Abbots Hay to the lane leading from Kimpton Mill to Codicote Bottom Farm and proceeding thence in an easterly direction along the centre of the first mentioned lane until it reaches a point immediately opposite the South-western boundary of the field numbered 359 on the said Ordnance Survey Map from whence it proceeds in a South-easterly direction along the said South-western boundary of the said field numbered 359 until it reaches the Southern boundary of the said Parish which said District is coloured pink on the plan annexed hereto and thereon numbered 1.

" 2. It is proposed to separate the following District from the Parish of Kimpton in the said County of Hertford and Diocese of St. Albans and unite the same for Ecclesiastical purposes to the adjoining Parish of Ayot St. Lawrence in the same County and Diocese.

" Such District shall consist of that portion of the said Parish of Kimpton which lies to the South and East of an imaginary line commencing at a point in the Eastern boundary of the said Parish where the centre of the footpath leading from Ayot St. Lawrence Church to the lane passing Bibb's Hall crosses such boundary and proceeding thence in a Westerly direction along the centre of such footpath until it reaches the centre of the last mentioned lane whence the said imaginary line turns in a Southerly direction along the centre of the said lane until it reaches a point immediately opposite the North-eastern corner of the field numbered 175 on the Ordnance Survey Map for the said Parish from which point it proceeds in a Westerly direction to such North-eastern corner of the said last mentioned field and along the Northern and Western boundaries of the said field and the Northern and Western boundaries of the wood or coppice numbered 177 on the said Ordnance Map until it reaches the Southern boundary of the said Parish which said District is coloured green on the said plan annexed hereto and thereon numbered 2.

" 3. And it is also proposed to separate the following District from the Parish of Sandridge in the said County of Hertford and Diocese of St. Albans and unite the same for Ecclesiastical purposes to the adjoining Parish of Ayot St. Lawrence in the said County and Diocese.

" Such District shall consist of that portion of the said Parish of Sandridge which lies to the North of an imaginary line running along the centre of the road leading from Wheat-hampstead to Codicote which said District is coloured yellow on the plan annexed hereto and thereon numbered 3.

" 4. The inhabitants of the said respective Districts shall not in future be entitled to any accommodation in the said respective Parish Churches of Codicote, Kimpton and Sandridge (except nevertheless any person or persons possessing a legal right by Faculty or otherwise to any pew or sitting within the said respective Churches and who may not be willing to relinquish and give up the same) and shall be exonerated from all liability to repair the said respective Parish Churches of Codicote, Kimpton and Sandridge but shall be entitled to accommodation in the Parish Church of Ayot

St. Lawrence and shall be liable subject to the provisions of the Compulsory Church Rates Abolition Act, 1868, to the repair of the said Church.

" 5. The Incumbent of the Parish of Ayot St. Lawrence shall have the sole and exclusive cure of Souls within the above mentioned Districts.

" 6. No alteration shall be made in the Patronage or endowments of any of the said Benefices.

" We, the Reverend Edward William Lane-Claypon of Park, Truro, in the County of Cornwall, Victor Charles Ames of The Manor House, Marylebone Road, in the County of London, Esquire, and Arthur William Stileman of 7 Bedford Row, in the said County of London, Esquire, being the Patrons or persons entitled to present to the Benefice of Ayot St. Lawrence in the County of Hertford and Diocese of St. Albans in case the same were now vacant, and the Reverend Armar Corry Vully de Candole the Incumbent of the said Benefice of Ayot St. Lawrence, Randall Thomas, by Divine Providence Lord Archbishop of Canterbury, Primate of All England and Metropolitan, being the Patron or person entitled to present to the Benefice of Codicote in the said County and Diocese in case the same were now vacant, and the Reverend William D'Abzac Crofton the Incumbent of the said Benefice of Codicote, the Right Honourable Thomas Walter, Viscount Hampden of The Hoo, Welwyn, in the said County of Hertford, being the Patron or person entitled to present to the Benefice of Kimpton in the said County and Diocese in case the same were now vacant, and the Reverend Arthur Thellusson Whyte-Venables the Incumbent of the said Benefice of Kimpton, the Right Honourable Albert Edward John, Earl Spencer, being the Patron or person entitled to present to the Benefice of Sandridge in the said County and Diocese in case the same were now vacant, and the Reverend Charles Edward Quin the Incumbent of the said Benefice of Sandridge, do hereby respectively signify to Your Grace our several consents to the Scheme above proposed and set forth and to every matter therein contained.
